### WBNQ'S "BENEFITS – LEAH MARLENE" CONTEST OFFICIAL RULES

The Station will conduct the **WBNQ's "Benefits – Leah Marlene"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
