WBNQ'S "CHICKEN SALAD CHICK GIVEAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBNQ-FM ("Station"), 236 Greenwood Ave., Bloomington, IL 61704, during available business hours Monday through Friday, on the Station website www.wbnq.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WBNQ's "Chicken Salad Chick Giveaway"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding dual Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the following Illinois counties: Peoria, Woodford, Tazewell, Livingston, McLean, Logan, DeWitt, or Piatt, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 90 days, and whose immediate family members or household members have not won a prize from the Station valued at \$500 or more in the last 90 days Void where prohibited by law. - 2. Contest Period. The Contest entry period will begin at 6:00am CT on May 30, 2023 and will run weekdays from 6:00am until 10:00am through 10:00am CT on June 2, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.**

Listen to the Station during the Contest Period. The Station will give the cue to call and announce three (3) statements. Listeners must call the Station at 309-828-1015 and tell the Station which statement is a Lie. The first (1) caller to the Station to correctly identify the Lie will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between</u> <u>Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.

Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
